A legal non-conforming use is a use which is not currently permitted by the Zoning By-law in effect today, but:

- Was legally established under the Zoning By-law in effect at the time the use commenced;
   AND
- Has continued uninterrupted and is in operation today.

These "tests" or criteria are established by the Planning Act.

Town of Caledon, Planning & Development Services staff offer the opportunity for an applicant to submit an application to establish a legal non-conforming use, and, where the tests are met, Planning staff will provide confirmation of the use in writing.

It is highly recommended that an applicant consult with Town of Caledon, Planning & Development Services staff prior to submission of an application.

To submit a Legal Non-Conforming Use application, the applicant must submit this application form together with the following information to Planning staff:

Owner Authorization permitting the applicant to act on the Owner's behalf to submit the application, if the applicant and the property owner are not the same person;

Application fee payment in accordance with the applicable Town of Caledon Fee By-law; and,

All supporting evidence being relied upon by the applicant to prove the use meets the criteria above.
